

## **OUR MISSION**

#### PROGRAM OVERVIEW

All withdrawal management services provided by our agency are team-driven, including input from clients, and their physicians, as well as other community agencies providing additional services. The care is Client-directed with a focus on developing strengths and resiliency.

- Be accessible, culturally safe and address barriers to access

#### WHAT WE OFFER

- 24-hour medication support with managing withdrawal symptoms.
- A 4 bed (Williams Lake) and 8 bed (Castlegar) facility providing a warm, inviting environment.
- A safe, caring and non-judgmental environment to support individuals on their road to recovery.
- Professional staff to help plan your recovery planning and guidance to further treatment options.
- Average of 3 5 day stay, depending on severity of withdrawal symptoms and planned discharge.
- A team of professionals (nurses and withdrawal management workers) focused on regular monitoring during withdrawal, group programming sessions, supportive counselling, meals, and social and recreational opportunities based on the individual needs and goals of the client.

#### **ENTRY CRITERIA**

- Age 19 and over who voluntarily seek withdrawal management.
- Living in the Interior Health Authority geographic region where the program is offered.

#### WHAT'S NEXT?

You will need to meet with your referral agent (physician, health authority team member or nurse practitioner )for an admission assessment and referral into the withdrawal management program. Referral forms are available online at www.axis.bc.ca.

It is recommended that all individuals as part of the continuum of care have plans to receive further treatment care once completing withdrawal management. Our team will assist in developing the next steps in your path to recovery through our discharge planning. We work closely with physicians, Interior Health and our community partners to ensure this is in place upon leaving the program.
