Dear Nominee:

To become a Candidate, there are requirements you will need to complete before the deadline specified in the *Xatśūll Election Code 2024*, which govern the election process. It is recommended that you review the Code so that you are familiar with the entire election process. Only Electors who meet the requirements of a Candidate as set out in the Code may be nominated.

To become a Candidate, a Nominee must file the following documents with the Electoral Officer by 8:30 PM on April 28, 2025:

a Notice of Acceptance of Nomination;
a sworn Declaration confirming that they have read and understood the Council Code of Conduct, the Council Oath of Office, Declaration of Confidentiality and Council Roles and Responsibilities, and if elected, they will abide by them; and
a summary of their Election platform in accordance with guidelines provided by the Chief Administrative Officer. Summaries of Election platforms may be in written or video format.

If the above documents are not received by the Electoral Officer by 8:30 PM on April 28, 2025, you will not be a Candidate in the Xatśūll First Nation 2025 Election.

There shall be an All-Candidates Forum on April 29, 2025, at 5:30 PM in the Xatśūll First Nation Gymnasium. All Nominees wishing to be a Candidate in the Election must participate in the All-Candidates Forum. A Nominee who:

- a. does not participate in the All-Candidates Forum either in-person or by videoconference; or
- b. participates in the All-Candidates Forum by videoconference but does not explain the circumstances that have prevented them from being at the Forum in-person,


shall not be a Candidate in the Election and their name shall not appear on the ballot.
