Registered Members who are eighteen (18) years of age and older as of the date of the Election may vote in this Election and shall form the Voters List.

Electors who are at least 18 years of age on the day of the Nomination Meeting may nominate candidates in-person at the Nomination Meeting OR by delivering or mailing a completed, signed, and witnessed *Nomination and Voter Declaration Form*, which must be received by the Electoral Officer **before** the start of the Nomination Meeting.

To be eligible for candidacy, an Elector must meet the following criteria:

- a) be at least 18 years old on the Election Day;
- b) not currently serving a jail sentence;
- have not, within 10 years prior to the Election Day, been convicted of an offence prosecuted by indictment, except for an offence committed in support of Secwepemc title and rights;
- d) have not, within 10 years prior to the Election Day, been convicted of a sexual offence, or an assault against a family member or intimate partner;
- e) have not been determined by a civil or criminal court to have committed theft, fraud or improper appropriation of the funds of Xatśūll or a Xatśūll-Empowered Entity;
- f) are not currently prevented from serving on Council by a decision of the Appeal Board; or
- g) are not overdue in the payment of a debt to Xatśūll or a Xatśūll Empowered Entity unless they are in good standing with respect to a payment plan or other repayment arrangement approved by an authorized representative of Xatśūll or the relevant Xatśūll-Empowered Entity.

To become a candidate, a Nominee shall, within 6 days after the end of the Nomination Meeting (April 28, 2025), file the following documents with the Electoral Officer:

- a) a notice of acceptance of nomination;
- a sworn declaration confirming that they have read and understood the Council Code of Conduct, the Council Oath of Office, Declaration of Confidentiality and Council Roles and Responsibilities, and if elected, they will abide by them; and
- a summary of their Election platform in accordance with guidelines provided by the Chief Administrative Officer.

The Voters List, Election Code, and supporting documents shall be available at the Xatśūll Administration Office; can be requested from the Electoral Officer; and will be available on the election webpage:
